Investment Objective

The objective of the Fund is to provide investors with a strategy that delivers strong positive returns when global equity markets experience material declines and volatility is high and costs comparable to, or less than other systematic derivative based hedging strategies such as rolling puts. The Fund aims to have a negative beta to equity markets. The nature of the strategy is expected to experience a degree of loss during periods when equity markets rise and experience low volatility. It is therefore intended to mitigate other investment exposures an investor may have in their overall portfolio. Invested capital is at risk and there is no guarantee that the objective will be attained over any time period. The Fund is actively managed and no benchmark is used for performance comparison or portfolio construction.

Sub-Advisor and Strategy Overview

The Fund is managed by the Aberdeen Alternatives team which has over 25 years' experience in alternative investments. The ASI Global Risk Mitigation index has been live since July 2019, with the Fund launching in June 2022.

The Fund, indirectly through its investment in a swap referencing the ASI Global Risk Mitigation index will pursue a multi-strategy and multi-asset approach implemented across a range of quantitative investment strategies (the "GRM Portfolio") to deliver the investment objective described above.

Investment Thesis

The GRM Strategies to which the Fund will seek to gain exposure are: First Risk Strategies, Defensive Factors, Systematic Trend Following Strategies and Tail Risk Strategies. The allocations to the systematic investment strategies within the GRM Portfolio are determined by using a combination of quantitative portfolio construction methodologies and qualitative assessments, which together are intended to deliver a robust negative correlation profile to equities while allowing for added value from dynamic asset allocation.

Global equities were strong in September supported by optimism around US monetary policy and accelerating investment in the technology sector. Shares rose in the US, the UK, Japan, emerging markets and most continental European countries. The MSCI World Index returned 3.25%. Technology, especially Al, remained in the headlines, as the Trump administration engineered a US acquisition of TikTok. Oracle shares surged on exceptionally strong cloud demand. Emerging-market indices were also strong. China led the gains, helped by Al enthusiasm and further moves by the government to open the country's markets internationally. Precious metals prices surged, driven by dovish central bank policy and US government uncertainty, along with Indian demand ahead of festivals and anticipated duty changes. However, energy prices declined, with oil pressured by expectations of increased OPEC+ supply. While interest rates were kept unchanged in the eurozone and the UK, the Fed cut interest rates in September, noting labour market weakness even as inflation ticked slightly higher. Corporate bonds outperformed sovereign bonds, although riskier high-yield debt fared slightly worse than investmentarade bonds.

The GRM strategy had a negative month with losses in First Risk and Defensive Factors only partially offsest by gains from Trend Following. Tail Risk strategies were flat. Within First Risk the biggest detractors were long VIX futures and a basket of Index Put Options. In Defensive Factors the biggest detractors were Commodity Backwardation (long energy futures) and Interest Rate Volatility strategies. Trend Following had gains across foreign exchange, Credit, and Commodities, with the biggest contributors being long positions in precious metals.

The Fund will make extensive use of total return swaps to reduce risk, reduce cost and / or generate growth consistent with the Fund's risk profile, if market prices are expected to rise ('long positions') or fall ('short positions').

The strategies that the Total Return Swap reference may themselves have high notional leverage as a result of the exposure to derivatives.

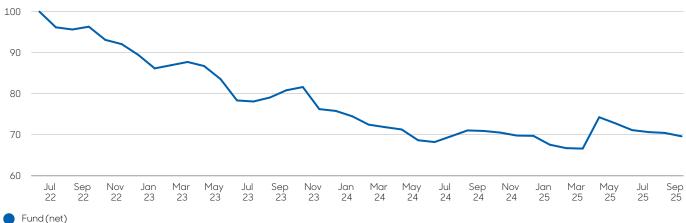

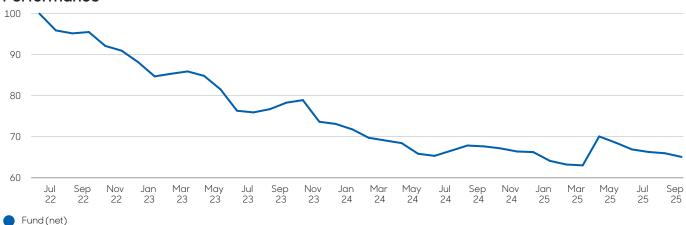

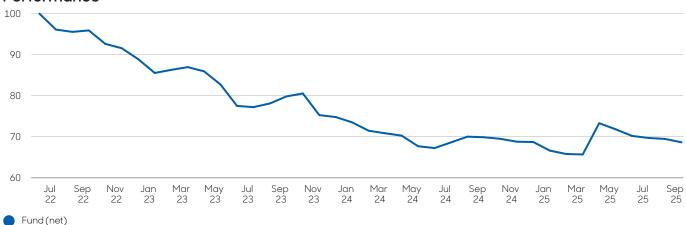

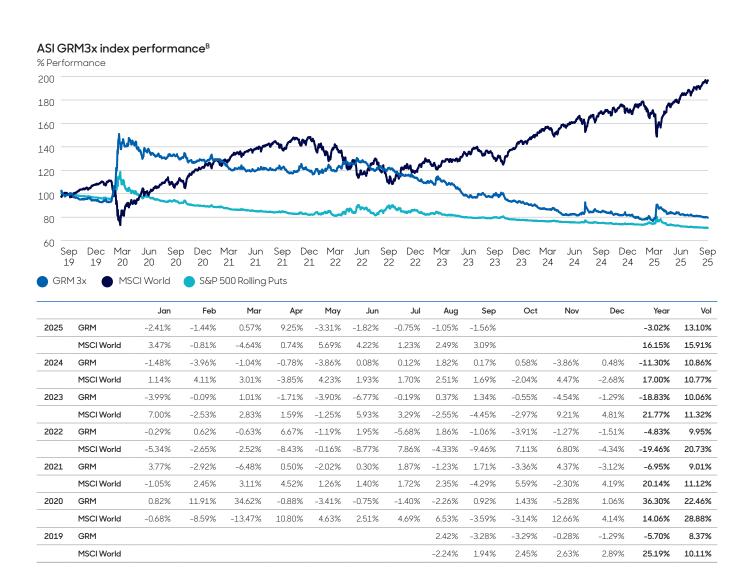

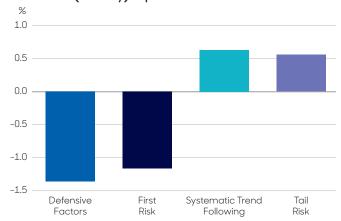

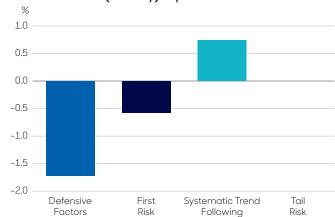


Index return (monthly) September 2025^c
